OF EXPLOSIVE LICENSES**

Dear Sir,

As you are aware that explosive licenses issued at district level are being discouraged as a security measures. The authorities concerned have advised the mine owners to apply for EL-3 (Explosive License). One of the pre-condition for the grant of this category of License is to indicate the names of certified shot-firers. With a view to facilitate the mine owners, a condensed course has been organized by the joint efforts of PMOA and Chief Inspectorate of Mines, Punjab at Training Mine Katas on 9th and 10th of July 2017 (9 a.m. – 4 p.m. each day). In order to, meet the incidental charges, each participant will be required to pay registration fee of **Rs. 1000/-** at the **Training Mine Reporting Counter** on **9th July at 8:00 a.m.**

Kindly depute at least two persons from each company for receiving the requisite knowledge. The participants shall be awarded the certificate in recognition of their participation and successful evaluation in the course.
