Following Sealed tenders are invited in the name of "Chief Inspector of Mines, Punjab, Lahore" for development project titled "Establishment of Mines Rescue & Safety Sub Station, Ara / Basharat, Tehsil Choa Saiden Shah, District Chakwal" for the supply of different items at the consignee's end i.e. Choa Saiden Shah, District Chakwal.
